AnzenOT – 30-Day Free Trial Terms & Conditions Last Updated: June 9, 2025

These Terms & Conditions ("Terms") govern your use of the 30-day free trial account ("Trial Account") for AnzenOT's SaaS platform (the "Service"). By registering for or using a Trial Account, you ("You" or "User") agree to these Terms. If You do not agree, do not register or use the Trial Account.

1. Trial Period & Eligibility

- **Duration.** The Trial Period begins on the date You complete registration and lasts for thirty (30) days.
- Eligibility. Trial Accounts are available to new accounts only. AnzenOT may refuse, limit, or cancel any Trial Account at its discretion.

2. Account Registration & Credentials

- **Accurate Information.** You agree to provide true, accurate, current, and complete information during registration and to promptly update such information.
- Credential Security. You are responsible for maintaining the confidentiality of Your login credentials and for all activity under Your account.

3. Scope of Use & Limitations
